

PIREPS AUTO SHIPPING LLC, Contract Terms and Conditions

1. All vehicles transported are fully insured by the carrier, as mandated by the US Federal Government. All damage must be properly noted on the delivery receipt or bill of lading while the driver is present and then submit in writing within 10 days business days of delivery.
2. **PIREPS AUTO SHIPPING LLC** agrees to make all efforts to provide the most expedient shipment of your vehicle(s). However, **PIREPS AUTO SHIPPING LLC** cannot guarantee pickup or delivery on a specific date. For an additional fee, unrestricted auto carriers in some areas may make appointments for pick up.
3. Transport of the vehicle(s) will be door to door. Should the carrier be unable to pickup or deliver to the specified address due to height, length, or weight restrictions, it will then be the owner's responsibility to meet the carrier at a location determined by the carrier to be as close as possible to the specified address where the vehicle can be loaded or unloaded. If the owner or shipper is unavailable at delivery, the vehicle will be placed in storage. Owner will be responsible for any storage or terminal fees resulting in unavailability of Owner.
4. The price for shipping (vehicle(s)) from place to place is \$_____. Prices are valid for vehicles shipped within (10 business days of the date of this quote. With proper notice, it will take approximately one to four days for pickup from (place) terminal.
5. If this order is canceled before a period of seven business days has passed from the requested available pickup date, an administration fee of \$50 (\$100 for Hawaii and overseas orders) plus any additional fees incurred by **PIREPS AUTO SHIPPING LLC** will be charged to the client. Additional fees may include charges to **PIREPS AUTO SHIPPING LLC** by the motor carrier if the order is canceled after the vehicle has already been scheduled for transport and/or fees pertaining to paperwork for overseas or Hawaii orders. The requested available pick up date is the date on the shipping order or the next business day after the order is received by **PIREPS AUTO SHIPPING LLC** whichever is later. If the shipper wishes to change the requested available shipping date, there will be no charge provided a motor carrier has not already been dispatched to pick up the vehicle.
6. The vehicle is to be tendered to the carrier in good mechanical condition. Should the vehicle become inoperable during transit, the inoperable fee will be determined by the motor carrier, and any and all fees must be paid upon delivery by cash or certified check.
7. Neither **PIREPS AUTO SHIPPING LLC** nor the carrier shall be liable for damage to exhaust systems and/or antennas or for damage caused by freezing and/or leaking fluids. All luggage and personal property are to be confined to the trunk of the vehicle and are shipped at the owner's risk. There shall be no guns, explosives, flammable products, valuables, alcohol, jewelry, ammunition, drugs (including prescription medicine), pets, plants or audio, video or electronic equipment left in the vehicle. Neither **PIREPS AUTO SHIPPING LLC** nor the carrier will be liable for damage resulting from items placed in the vehicle. If the vehicle is being shipped overseas, the vehicle must be completely empty except for factory-installed equipment. "Overseas" includes shipments to Hawaii. Any items left in the vehicle will be removed at Owner's expense.
8. It is also agreed that Canadian law governs this agreement and the rights and obligations of the parties pursuant to the agreement and any legal actions arising out of this agreement shall be brought in the Province of British Columbia, Canada.

This agreement supersedes all oral and/or written agreements between the Owner/Shipper and **PIREPS AUTO SHIPPING LLC** and may not be changed except when in writing by **PIREPS AUTO SHIPPING LLC**.
